#### ...Message from Mike

I start this message as I do every first edition of a new year, "it's hard to believe we're already into April." As you will read, the first quarter of the year was a very active 91 days, with three major redevelopment projects taking priority. MSLH, LLC purchased the former Scotland School for Veterans Children in early March, and extensive renovations have begun to retrofit the property into a summer camp for Jewish youths. The property will be known as *Camp Mulca* and reservations are being accepted for the summer of 2024.



I am pleased to report that there are ongoing negotiations pertaining to the potential sale of the Chambersburg Mall. While I continue to regard former baseball great Yogi Berra as one of the great philosophers of any era, especially his classic advice "it ain't over till it's over", the fact the Mall discussions are taking place is the first critical step in the potential purchase and redevelopment. I am optimistic that a sale can be consummated and that a mixed-use redevelopment plan will merge sooner rather than later.

Finally, Miller Investments has effectively repurposed the former Tamarack Industrial Park, which is located within the confines of the larger Cumberland Vally Business Park. Miller Investments has transformed roughly 450,000 square feet of marginally functional industrial space into readily available space that can support users ranging from light industrial-to-logistics-to very simple warehouse and storage requirements.

These three projects are important as each is restoring the economic vitality of once iconic properties that fell into disrepair. I also bring them to your attention because they help dispel the myth that our economic development strategies are somehow singularly focused on warehousing and distribution/ logistics. The FCADC mission is to support economic diversity and to avail resources, to the greatest extent possible, to businesses large and small in every business sector. If our office can be of assistance to your efforts, I encourage you to reach out. At a minimum, we can have a conversation to determine if and how we might be able to support your efforts.

FCADC Lot 5 Wharf Road Project Progressing Plans continue to take shape on the potential

development of a 30,000 square foot industrial building on Lot 5 within the Wharf Road Industrial Park in Waynesboro. Originally, plans called for the development of up to three building lots on the 20-acre parcel, however those plans have been scaled back to one building with the potential for additional development in the future. The FCADC has applied for site work funding from the new PA SITES program administered through DCED. The program provides funding for the development of "pad-ready" industrial sites throughout the Commonwealth. When completed, the FCADC will market the property as available for sale or lease.

On March 7th the FCADC hosted its annual State of the Economy breakfast at Green Grove Gardens in Greencastle. More than 325 community and regional business leaders attended the event. Mike Ross provided an overview of the FCADC's successes throughout 2023, as well as a preview of 2024 economic development efforts. Presentations were also given by Jamison Howe, Site Leader, re:Cycle Reverse Logistics and David Blenckstone, General Manager, The Hagerstown Flying Boxcars. re:Cycle Reverse Logistics provides electronic recycling of Amazon data center electronics. The Hagerstown



Flying Boxcars are the newest independent minor league baseball affiliate. A new stadium complex is currently under construction in downtown Hagerstown. Finally, former Franklin County Commissioner, David Keller was presented with the FCADC *President's Award* in recognition of his economic development efforts as a County Commissioner.

# Former Scotland School for Veteran's Children Campus Sold

The former Scotland School for Veteran's Children (SSVC) was sold on March 6<sup>th</sup>. Purchased for \$9.1 Million by New York-based MSLH, LLC, the campus will be repurposed into a summer camp for Jewish youths. To be known as Camp Mulca, conceptually, it will be similar to Capital Camps in Washington Township. The renovations are proceeding at breakneck speed as the first group of campers are tentatively scheduled to arrive on July 1. It should be noted that the sale did not include the 40 acres located on the "other side" of the Norfolk Southern rail line that bisects the property. While the primary mission is to operate Camp Mulca, the ownership is seeking opportunities to partner with the community to make its many amenities available. To that point, our staff has been assisting the new



ownership in making necessary connections with local elected and community leaders.

#### **Letterkenny Army Depot (LEAD) Unveils Modernization Plan** \$1.2 Billion of Improvements through 2035



The US Army has kicked off its 15-year, \$18+ Billion modernization plan to upgrade its facilities, processes, and workforce to bring its organic industrial base into the 21st Century. Included in the plan is the upgrading and modernization of facilities at the Letterkenny Army Depot. To date, \$700 Million of improvements to LEAD facilities have been planned through 2025 with an additional \$500 Million of capital investment through 2035. Near term investment at LEAD includes a new fire station and missile maintenance facility.




#### Leg Up Farm Receives Federal Funding
