CHAMBERSBURG MSA JANUARY UNEMPLOYMENT RATE AT 3.6%

HARRISBURG (MARCH 20) – The not-seasonally adjusted unemployment rate for the Chambersburg Metropolitan Statistical Area (MSA) was at 3.6 percent in January 2024. Pennsylvania's rate was at 4.3% and the national rate was at 4.4%.

Seasonally adjusted total nonfarm jobs in the Chambersburg MSA were up slightly over the month to 63,200 in January and tied the record high set in October 2024. Over the year, jobs were up 3.6 percent (+2,200) in the MSA, while jobs statewide grew 1.2 percent from last January.

January Not Seasonally Adjusted Nonfarm Jobs Detail

Among the seven published supersectors, five were essentially unchanged from December levels. Trade, transportation, and utilities declined 600 seasonally. Over the year, the largest movement was a gain of 1,100 in trade, transportation, and utilities.

NOTE: Because the data included in each month's press release (primarily civilian labor force and nonfarm jobs data) are sample based, the data are subject to revisions. Once each year, estimates are adjusted to new levels based on additional or revised information collected after the initial release of the data (called a benchmark). Seasonal adjustment factors for historical labor force and nonfarm jobs data have also been updated. Additionally, the revised data reflects new geographic area definitions based on the 2020 Census Area Delineation. Revisions to the nonfarm jobs series through 2024 have been completed and are reflected in the January news release. **Revisions to the historical labor force series have not been completed and are not yet reflected in the January news release and BLS has temporarily stopped production of substate seasonally adjusted LAUS data until further notice.** Historical not seasonally adjusted labor force revisions are expected to be completed by the release of March data in late April 2025. FOOTNOTES

1) Estimate of workers by place of residence. These data are controlled to state Current Population Survey (CPS) data which adjusts for commuting and dual job-holding. Workers are counted where they live only once regardless of the number of jobs they may hold. All in-depth inquiries relative to the estimating methodology should be addressed to the Bureau of Labor Statistics, U.S. Department of Labor. All data are subject to revision during annual benchmarking.

2) Includes wage and salary workers (including agriculture), self-employed persons, and unpaid family workers (including agriculture), domestic workers, and persons involved in labor-management disputes.

3) Unemployed as percent of civilian labor force, computed using unrounded data.

4) Due to methodological changes and conversions to the 2020 Census-based area delineations, seasonally adjusted substate area LAUS data is not available until further notice.
